As of this meeting date, March 18, no decision has been made about the status of the school for next year. Father Kerry said that the diocese is still meeting about this and that he has been told to stay out of it.

Principal's Report: Shawn went over Principal's report which was two months together since we did not meet in February. See report.

Finance Council Report: Finance Council has not had a chance to review donations. Father Kerry said Tuition (income) was \$30,000 and that he was hoping for \$40,000 for the month. He had to get another \$75,000 out of the Parish's Savings account in February to meet the parish's financial obligations, This is the third time he has had to get that amount of money from the Savings account. It is possible, he said, that this will need to be done in May or June.
